


Figure 1: Market Share of AI from a Regional Perspective Source: PWC, Forbes, IBM




Figure 2: How AI is Transforming the Roles and Responsibilities of Nurses




Figure 3: AI Addressing Current Challenges for Nurses




Figure 4: Integrating AI into Nursing Practices




Figure 5: Factors determining the lack of adopting AI Technologies
